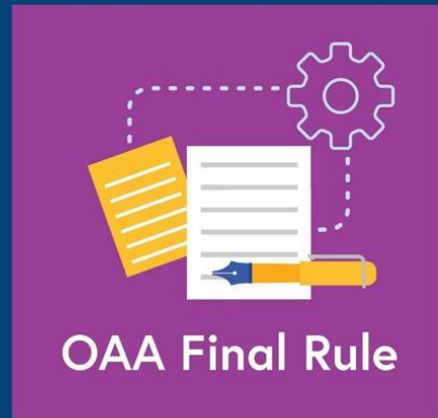
# OAA Program Data

- FY 23 was second year for reporting under new State Program Report (SPR) requirements using OAAPS for Title III and Title VII Chapter 3 & 4
- National Survey of OAA Participants (NSOAAP) continues to provide critical national outcome data on OAA services
