## What to Understand About Aging in

## Indian Country

- Majority of Tribes define an Elder at 55+ –
   OAA only funds 60+ and does not fund UIOs at all
- Most Elders today are either survivors of boarding school trauma or the children of trauma survivors – Fear of being removed from the home is a tremendous barrier
- COVID has reduced the life expectancy of AI/AN/NH peoples to numbers not seen since WW1 (CDC currently stated the life expectancy aggregate at 65)

- Nearly a third of Elders are disabled (29%)
- 89.7% of Native Elders have at least one chronic disease
- 38.2% have a family member providing support
- 29.8% are raising/caring for grandchildren


## HCBS Waivers – Cheese on the Bologna

Sandwich of Medicaid



- There is **NO IHS Funding** for LTSS/HCBS to Tribes
- OAA Funding Formula Barriers (Age and Mandated Service Population)
- Medicaid is the Single Largest Payor of HCBS/LTSS to Indian Country





There are 2 ways to be eligible for Medicaid:


- 1) Financial
- 2) Functional (Needs Based Waivers— Even if over income!)



### GENERAL MEDICAID HCBS WAIVER PROCESS

Frail Elder or Adult with Disability or Chronic Illness

Tribes/Providers
give services
listed on the Plan
and send bill to
the HCBS
Medicaid Waiver
Agency\*





Tribes/Providers
give services listed
on the Plan and
bill to the HCBS
Waiver Agency.\*
Some services may
be given through
schools

\*This is the <u>basic</u> process. There will be specific differences in each State.



### Federal Provisions for Tribes in Medicaid – Sovereign Nations with Government Agencies

TRIBES AS PROVIDERS	Native Enrollees of Medicaid HCBS	
Must be reimbursed for Medicaid allowable services provided to Medicaid (IHCIA, ISDEAA, ANAIDRA)	Right to choose IHS provider for Medicaid services (IHCIA, ANAIDRA, ARRA Sect 5006, SSA, OAA)	
Exempted from contracting with MCOs under federal law (ARRA, Sect. 5006)	Right to have Tribal program staff present as an advocate	
Covered Entities (HIPAA) as Insurance Plan, Providers and Public Health Authorities*	Tribal GWE funds not counted as taxable income (IRS 138E)	
May pay for member spend-downs (IRS 138E)	Over-qualify but under-enrolled in Medicaid





HOME DELIVERED MEALS	2,583,369	\$5.50/meal	\$14,208,529.50
PERSONAL CARE	45,333	\$14.60/Hour	\$661,861.8
HOMEMAKER	109,438	\$14.60/hour	\$1,597,794.8
TRANSPORTATION TRIPS	762,798	\$0.55/Mile, Average round trip 40 miles	\$16,781,556

#### Tribes as HCBS Medicaid Provider

- Research state Medicaid requirements for the service you want to provide
- Check to see if Tribe has a current Medicaid Provider ID (NPI), if not apply for free <u>online</u>
- If needed, complete application for the appropriate Medicaid Provider type(s) in the state Medicaid program



# Enroll Your Members in Medicaid/Waivers

- Aid people (especially Elders!) in enrolling and provide advocacy and support for functional screens
- Include Tribal Health programs and other areas that help with insurance and Medicaid
- Collaborate across programs to identify Elders and others in need of supports – Talk to the boots on the ground like CHRs, Nurses, Aging Directors, Social Services and other health and support staff who see clients and families
