

Federal Initiatives to Align Housing, Health, & Social Care

- Increased attention on health-related social needs (HRSNs), including housing
 - White House SDOH Playbook, HHS Call to Action, and ongoing federal interagency coordination
- Medicaid and Medicare HRSN policy updates expand support for addressing HRSNs
 - Medicaid 1115 waivers supporting state investments to address HRSNs
 - In Lieu of Services guidance for HRSNs in Medicaid managed care
 - CMS rules: new screening measures for SDOH for hospitals, physicians, and special needs plans, advanced payment incentives for Medicare ACOs, new codes in Physician Fee Schedule Final Rule



Opportunities to Align Housing, Health, & Social Care

- Health care contracts: source of funding for housing and services
 - Medicaid Managed Care, Medicare Advantage, D-SNPs, health systems, Accountable Care Orgs
 - Need local expertise on aging services, connections to diverse populations, ability to braid funding, and connections to an array of community supports
- Partnering with health care to address housing or other HRSNs: AAAs and CBOs may need additional capacity?
- Community care hubs: another avenue for health care contracting and braiding available funding to meet individuals' needs

Housing & Services Partnership Accelerator (HSPA)

Advancing Housing Stability and Community Living

Goal: Support states and communities to accelerate the development and implementation of innovative state strategies to provide housing-related activities and supports to persons with disabilities and/or older adults who are experiencing or are at risk of experiencing homelessness.

Why? The coordination of housing assistance and wrap-around supportive services—such as in the form of supportive housing—is a proven, cost-effective approach to assisting people with disabilities and chronic/complex health conditions to transition from homelessness, exit or avoid institutional settings, and live in the community.

Benefits to State Participants

- Opportunity to develop and expand knowledgebase
- Increased capacity to implement and strengthen strategies for providing housing-related activities, supports, and services







- Started pre-1115 waiver
- Need for specialization
- Supportive Housing is one tool in the toolbox



Foundational Community Supports

- Third Party Administrator
- Targeted to Medicaid
 beneficiaries age
 18+ with
 complex health
 needs

Risk Factors (one or more)

- Chronic homelessness
- Frequent or lengthy stays in an institutional setting (e.g. skilled nursing, inpatient hospital, psychiatric institution, prison or jail)
- Frequent stays in residential care settings
- Frequent turnover of inhome caregivers
- Predictive Risk Intelligence System (PRISM) score of 1.5 or above

Addressing Housing Stability with Medicaid Funding in Massachusetts

USAging Conference July 9, 2024













Maria is a 61-year-old Spanish speaking woman living in an urban setting. She has painful arthritis and type 2 diabetes. Her last A1C was more than two years ago and was 9.0+.

Her sole source of income is from a low-wage, part time position. Her 46-year-old son, who suffers from substance use disorder, moved himself in and refuses to leave. Maria is afraid of him and knows that he is stealing both pain medication and money from her.

Maria is now 4 months behind on rent and facing eviction. Her refrigerator has been broken for months and she also suspects mold in her home but is afraid to bring any of these issues to her landlord. Maria is depressed and anxious.

80%+ Medicaid members now enrolled in an ACO	4,500 primary care providers	Mass Health contracts with ACO to coordinate care under a member centered plan	 Common focus: Long Term Services and Supports Behavioral Health (including substance use disorders)

- Medicaid and Medicare flexibilities are increasing available funding for housing-related supports and services.
- AAA programs, services, funding, and network of local partners can play a role in addressing the rise in older adults who are experiencing homelessness.
 - Multisectoral collaborations are essential.
 - If capacity is an issue, consider the community care hub model.




